## **Risk Summary:**

#### Equipment and PPE:

- Mortar and pestle
- Glass stirring rod
- Graduated cylinder
- CHEO Level B Non-Sterile Compounding Standard PPE (mask, nitrile gloves, clean gown, hair bonnet +/- beard cover)

#### Procedure:

Always follow departments training protocols and policies and procedures that are currently in place.

- 1. Place tablets in the mortar. Pour a small amount of vehicle over the tablets before crushing.
- 2. Crush tablets to make finer particles, and a homogeneous smooth paste.
- 3. Continue to add vehicle until product is liquid enough to transfer to a graduated cylinder.
- 4. Rinse mortar several times with vehicle and transfer product to graduated cylinder.
- 5. QS to final volume with vehicle. Mix well.
- 6. Dispense in amber plastic bottles. Label bottle appropriately.
- 7. Before washing, rinse equipment into medication disposal bin, and not directly into sink.

#### **Quality Control:**

- Final Appearance: thick, white, opaque suspension
- Packaging: amber plastic bottles
- Storage: refrigerated or room temperature
- BUD: 60 days
